The women's education center provides training in literacy, sewing, cooking, craft work, business and life skills.

4b (Code: ) (Expenses \$ 286,543. including grants of \$ ) (Revenue \$ 151,037. ) The Mission and Volunteer Program was created to provide housing and opportunities for volunteers following the January 12, 2010 earthquake. It now provides safe housing at the organization's guesthouse for visitors participating in the Mission Experience trips or assisting with the organization's programs. The guesthouse also serves visitors that are in Haiti to further the organization's purpose.
