These programs were started to respectively address the root causes of child orphanhood - maternal death associated with pregnancy, labor, or delivery, and extreme material poverty. By empowering women to parent and financially provide for their children, these programs have significantly reduced the number of children relinquished to orphanages.

4b (Code: ) (Expenses \$ 471,495. including grants of \$ ) (Revenue \$ 97,793. ) The Mission and Volunteer Program was created to provide opportunities for volunteers following the January 12, 2010 earthquake. The program provides safe housing at the organization's guesthouse for visitors participating in the Mission Experience trips and assisting with the organization's programs and projects.
