The Women's program includes a maternity center and a women's education center. The maternity center helps provide education and medical care before, during and after birth. The women's education center provides training in literacy, sewing, cooking, craft work, business and life skills.

The Mission and Volunteer Program was created to provide opportunities for volunteers following the January 12, 2010 earthquake. The program provides safe housing at the organization's guesthouse for visitors participating in the Mission Experience trips and assisting with the organization's programs and projects.

The Poverty Programs include all the organization's general efforts to combat poverty in Haiti. They include direct individual assistance for health and education expenses, assistance with adoption issues and men's discipleship and business training through an on site bakery.
